**TERMS AND CONDITIONS**

CRANE MINIMUMS ARE BILLED PORT TO PORT UNLESS OTHERWISE SPECIFIED. STRAIGHT TIME IS FROM 7:00AM-3:30PM MONDAY-FRIDAY. OVERTIME IS ANY TIME BEFORE 7:00AM, THROUGH LUNCH WHICH IS 12:00-12:30PM OR AFTER 3:30PM. ANY HOURS WORKED OR TRAVELED DURING THESE TIMES WILL BE BILLED AT THE HOURLY OVERTIME RATES IN ADDITION TO THE HOURLY CRANE RATES. IN LIGHT OF THE EQUIPMENT PROVIDED BY P&G CRANE TO THE UNDERSIGNED, THE LATTER AGREES TO ASSUME FULL RESPONSIBILITY FOR THE EQUIPMENT FOR THE DURATION OF ITS USE UNTIL RETURNED. THE EQUIPMENT IS TO BE RETURNED TO P&G CRANE IN THE SAME CONDITION AS RECEIVED, BARRING NORMAL WEAR AND TEAR. ADDITIONALLY, THE UNDERSIGNED AGREES TO INDEMNIFY AND HOLD P&G CRANE HARMLESS FROM ANY CLAIMS, DEMANDS, LAWSUITS, OR RELATED EXPENSES ARISING FROM PERSONAL INJURIES (INCLUDING DEATH) OR PROPERTY DAMAGE INCURRED DURING THE USE AND OPERATION OF THE EQUIPMENT UNTIL ITS RETURN. THIS INCLUDES CLAIMS RELATED TO ANY ACTIONS OR OMISSIONS BY THE OPERATORS, IRRESPECTIVE OF THEIR EMPLOYER. FURTHERMORE, THE UNDERSIGNED COMMITS TO COVERING ALL LOSSES, COSTS, DAMAGES, AND EXPENSES— INCLUDING ATTORNEY FEES AND COURT COSTS— THAT P&G CRANE MAY INCUR IN RELATION TO RETRIEVING THE ENTRUSTED EQUIPMENT OR IN DEFENDING AGAINST ANY CLAIMS, DEMANDS, ACTIONS, OR LAWSUITS STEMMING FROM THE OPERATION AND USE OF THE EQUIPMENT, OR FROM ANY NEGLIGENT ACTIONS OR OMISSIONS BY OPERATORS WHILE THE EQUIPMENT IS UNDER THE CARE OF THE UNDERSIGNED. IT IS IMPORTANT TO NOTE THAT NO KOTECKI COVERAGE OR SIMILAR INSURANCE WILL BE PROVIDED.
